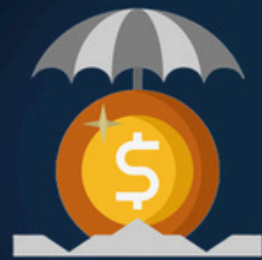
## INVESTMENT PLATFORM

### Organizational Entity

The Organizational Entity provides a unique, multi-layered investment solution (MTCP) offering 100% capital protection to investors in litigation finance. This significantly mitigates risks associated with market volatility and traditional bond investments.

### Insurance

The PIS Bond (PISB) acts as a crucial layer of protection within the MTCP structure. It's a surety bond, meaning it guarantees the performance of obligations to the LABN holders. If for any reasons the Organizational Entity fails to meet its obligations (e.g., due to underperformance or timing issues of the underlying litigation assets), the PISB steps in to cover the shortfall. This provides "Tier 1 capital protection," meaning it's the first line of defense for investors. The key aspect is that the PISB isn't just a promise; it's backed by a pool of capital pledges. This implies that there are assets dedicated specifically to ensuring the PISB can fulfill its obligations. 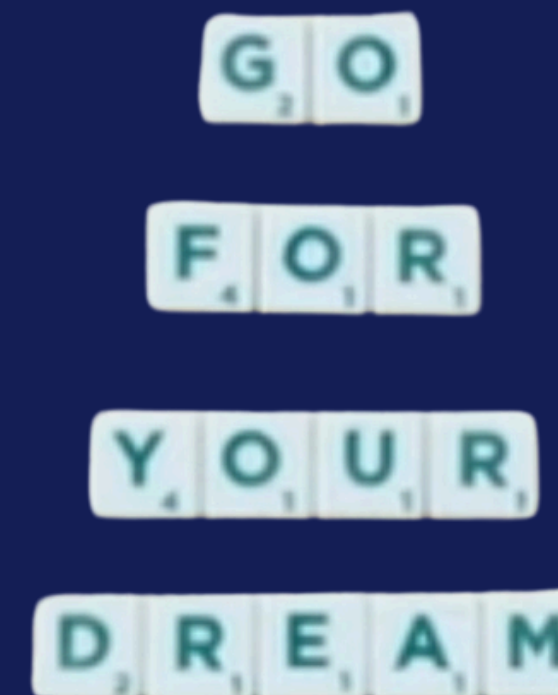

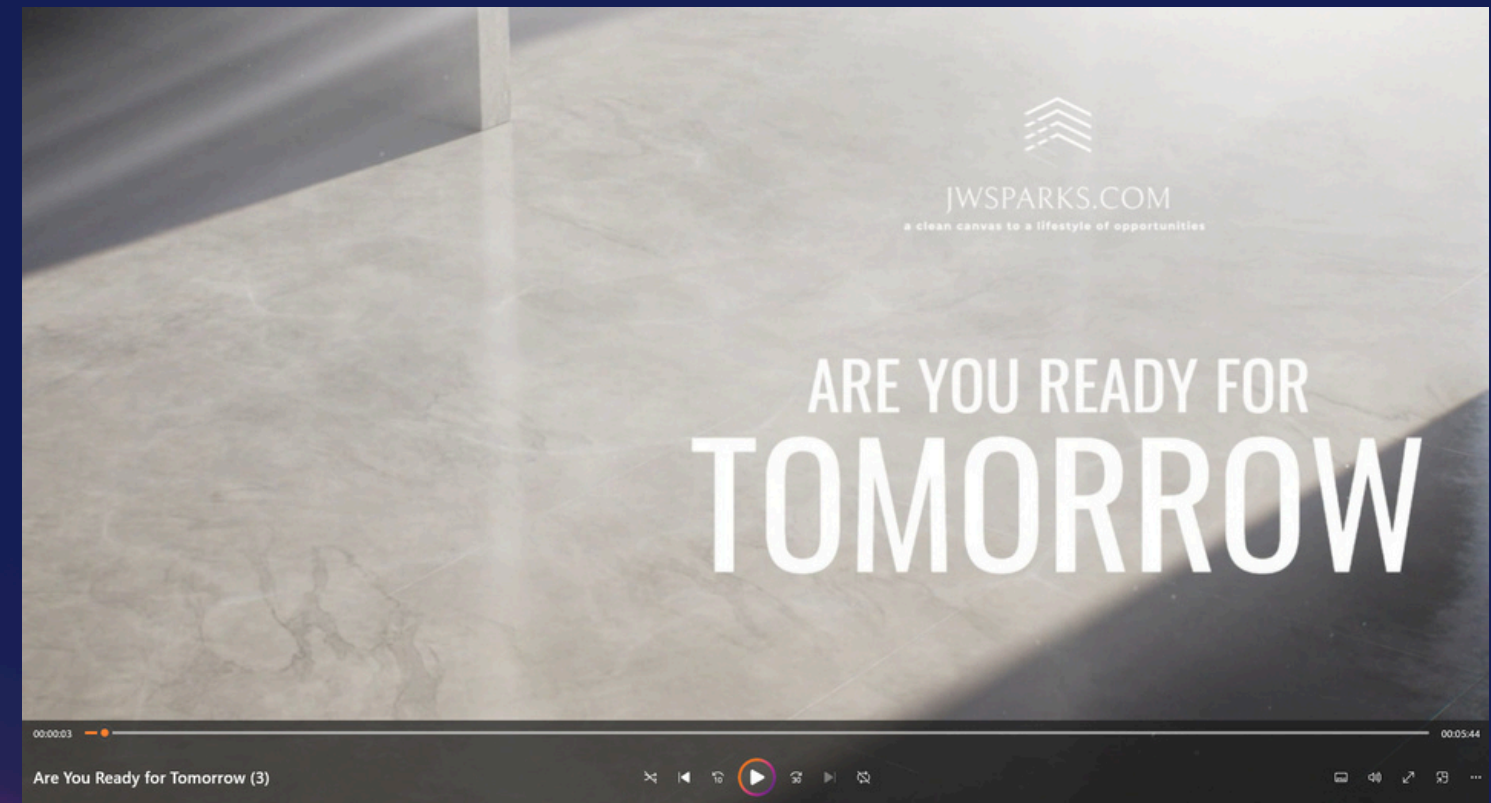
